Lunar New Year Added to School Calendar. The Governor signed legislation into law adding Lunar New Year to the list of holidays schools are required to observe and therefore all school districts must be closed on that day. The law, however, does not require school districts to observe the holiday if Lunar New Year falls on a Saturday or Sunday. While the law takes effect immediately, it will not impact the 2023-2024 school calendar as Lunar New Year falls on Saturday, February 10th, 2024.

New Civil Service Law Amendment, Governor Hochul signed bill S5494/A7155, which credits all time spent in a provisional civil service position towards the probationary period of the employee subsequently appointed into that position. A number of civil service positions do not run tests frequently, which creates a real challenge for people in provisional appointments (often in BOCES settings). This amendment is an important part of moving the provisional status for these employees to its intended role - a short, limited placement that supports staffing rather than eroding it.
